November 3, 2014, 2pm — ***E-rate 2.0 and Funding for Local Communities to Close the Digital Divide.*** According to the FCC, more than 80% of schools report that their broadband connections do not fully meet their current educational needs, with slow internet connections being the primary culprit. This session will provide an update on the status of e-Rate 2.0 and how municipalities can utilize e-rate funds to bring modern levels of broadband speeds to their schools and libraries, while keeping these revenues local.

December 1, 2014, 2pm — ***The Courts, The Hill and The FCC - A Year in Review and Setting the Stage for 2015.*** Our panel of experts will assess how 2014 affected policy and practice on key communications issues and will provide their views of what may be coming in 2015 - and how local governments can prepare.
