RUSHWORKS, established in 2001 in Texas, provides low-cost, high-performance television production and automation technology for several market sectors, including broadcast, cable and PEG channels, Houses of Worship, performance venues, and legal videography and courtroom presentation.



Rush Beesley, the company founder and President, will be sharing an overview of the company's technology innovations at the upcoming JAG meeting on Wednesday, May 27th at 12:12pm. You'll learn how they can sustain and enhance traditional production models, as well as how they can best be utilized in the evolving model of remote communications and interactivity which will likely be an expanded part of the "new normal" moving forward.

Rush has designed all the products and interfaces, driven by the company's mission to provide INTEGRATED MEDIA SOLUTIONS that increase PRODUCTIVITY, PROFITABILITY, and RETURN-ON-INVESTMENT. This is made possible by dedication to a basic rule appreciated by everyone: **K.I.S.S. Keeping It Super Simple** with simple user interfaces that insure that a single operator can do anything from creating a 24/7/365 playback channel – for broadcast, cable or OTT – to multi-camera productions using integrated robotic cameras and dolly shots.

Key items in the discussion will be:

1) the RUSHDOLLY™, a small but robust dolly that runs on aluminum channel track up to 32' in length, moving from a slow crawl to a brisk walking speed. It's integrated with the company's PTZ and PTX cameras and heads to provide integrated motion presets that create the visual magic of cameras in motion.



2) the A-LIST Streamster™, a tiny hardware/software solution (1.7" x 5" x 5") that lets you create your own Internet TV Channel. Schedule and playback 24/7 using the same powerful A-LIST software used by full power and low power TV stations around the world. It supports NDI in and out as well, and has templates for streaming to YouTube, FaceBook, Vimeo, Zoom and many more destinations.



3) the PTX™ Universal PanTilt Heads, available in two configurations for smaller and larger cameras, let you use your favorite camcorder or camera, including mirrorless and DSLR bodies and lenses, for PTZ video production.

The BABYZOOMER™ is a complementary option that lets you use non-power zoom lens from a variety of manufacturers with most cameras, including the popular Blackmagic Micro Studio Camera 4K and the URSA family.



4) the VDESK and REMO Integrated PTZ and PTX Production Systems, which provide all the typical capabilities for switching, transitions, effects (Chroma-key, Double-Box, etc.), internal recording and ISO recording, graphic overlays and more. You can control up to 12 devices, and utilize up to four NDI sources.



But VDESK is unique in offering THREE completely different user interfaces, any of which you can use at any time based on the type of productions you're doing. The CLASSIC displays PTZ camera panels with 8 named and saved presets per panel.

The PRODUCER interface uses an actual picture of your production set (if you wish) on which you place icons and/or pictures of participants. Then just touch the picture or icon of the shot you want to take and it automatically selects that shot on the Preview with a second camera, and can auto-take that shot – with the option of automatically fading a lower-third on and off.

The TalkingPoints interface is designed specifically for lecture and presentation capture, with the ability to record and stream the event simultaneously.

5) If we're emphasizing Remote, as in no one present, operation ... we just need to mention our VDESK, REMO and A-LIST BROADCAST systems all include a subscription to LogMeIn. Using that you can operate any of the systems from anywhere there is Internet access. That's much more important than someone sitting in the back of a room with a tablet and controlling the interface.

JAG Spotlight:

During this health crisis, we at HTTV have had to find creative ways to service our communities. Social distancing and executive orders have forced us to close our studio to the public, so we have had to find new ways to generate programming to keep our citizens informed during the pandemic. It helps to have a mayor who is both media savvy and media friendly. In addition to recording and distributing “virtual” town council meetings, an HTTV crew, observing all the appropriate social distancing requirements, has shot 25+ episodes of the Mayor reading children stories which are available on the channel, on demand, and on YouTube.

With all public gatherings cancelled for the near future, HTTV turned the Community Bulletin Board into a source for information on safety measures and local Covid-19 activities.

Lisa Allen, one of HTTV’s hosts, has started a new show by conducting virtual interviews with various organizations, community leaders, non-profits, and health and wellness experts talking about positive and informative news that has come out of our community during this unusual and difficult time.

Normally HTTV carries two different religious services, but given the current pandemic and the restrictions on large gatherings, at a pre-determined time each Sunday, HTTV carries the services from 4 different churches to help bring these events to a community in need of comfort.



Finally, thanks to a tip from local officials, two HTTV crews covered a drive by salute from the local police, fire and EMT squads to the men and women who work at Overlook Medical Center. At the same time we were shooting, a recovered Covid-19 patient from Overlook was also discharged which added to the drama of the situation. In addition to running the piece on the station, the footage that was generated by the HTTV crews was made available to Atlantic Health System for use on their website. Subsequently, a shot was used in a commercial that is running on all the local NY stations.

We hope the efforts we have made to provide hyperlocal content during this health crisis has helped to inform the people who live in the communities we serve. This

kind of hyper-local programming is something that we in the PEG community can uniquely provide during these difficult times.
