Here is an additional update to the threat of HR 3557. A couple weeks ago, the bi-partisan national organizations of local government officials National League of Cities (NLC), the U.S. Conference of Mayors (USCM), the National Association of Counties (NACo) and the National Association of Telecommunications Officers and Advisors (NATOA) sent a letter to House leadership reiterating their opposition to HR 3557 the American Broadband Deployment Act.
