In November, President-Elect Donald Trump selected current FCC Commissioner Brendan Carr to become the next chairman of the board. In addition to telecom issues, Carr outlined plans to reinterpret Section 230, the law that protects internet platforms from liability for their users' posts. "While there has been much discussion about whether or not the scope of Section 230 is appropriate, what everyone agrees on is that the authority lies with Congress, not the FCC."
